1 Name

Schedule 1—Amendments

Australian Transport Safety Bureau (Subsection 24(1)—Australian Transport Safety Bureau Non-SES Employees) Determination No. 2021/01

1 Section 10

Repeal the section, substitute:

10 Third annual adjustment of salary and allowances

- (1) Employees' salaries are adjusted by 3.00%, with effect on 4 August 2023.
- (2) Each adjustment is to be calculated based on the salary immediately before the adjustment under subsection (1).
- (3) First Aid, Fire Warden, Investigator On-call allowance (IOCA) and Health and Safety representative allowances are adjusted by the same percentage as salaries, with effect on 4 August 2023.
- (4) Each adjustment of an allowance is to be calculated based on the allowance immediately before the adjustment under subsection (3).
- (5) Schedule 3 has effect.

2 Schedule 3

Repeal the Schedule, substitute:

Schedule 3— Third annual adjustment—Salary and allowances on 4 August 2023

Note: See section 10.

1 Salary

On 4 August 2023, salary and pay point and broadband covered by column 1 of the following table is payable at the rate for that pay point (the *new rate*) described in column 3 of the table. This is an adjustment of 3.00% under subsection 10(1) of this determination.
